## **RESULTS OF ANNUAL GENERAL MEETING HELD ON 12 JUNE 2012**

At the annual general meeting of China High Speed Transmission Equipment Group Co., Ltd. (the “Company”) held on 12 June 2012 (“AGM”), a poll was demanded by the Chairman for voting on all the resolutions as set out in the notice of AGM dated 9 May 2012.

As at the date of the AGM, the issued share capital of the Company was 1,362,743,556 shares, which was the total number of shares entitling the holders to attend and vote on the resolutions at the AGM. There was no share entitling the holder to attend and abstain from voting in favour of the resolutions at the AGM. There were no shares of holders that are required under the Listing Rules to abstain from voting at the AGM.

The Company’s branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking. As more than one half of the total number of the votes held by the shareholders and authorised proxies who attended the AGM were cast in favour of all the following resolutions, all such resolutions were approved and passed by shareholders as ordinary resolutions.
